#### REPORT OF DIRECTOR – PUBLIC HEALTH, PROTECTION AND COMMUNITY SERVICES

#### 1. <u>PURPOSE OF THE REPORT</u>

1.1 The purpose of the report is to approve the submission of an application for funding of £128,400 to Welsh Government's Museums, Archives and Libraries Division for a Transformation Capital Grant to re-design and refurbish the interior of Treorchy library.

#### 2. <u>RECOMMENDATIONS</u>

2.1 It is recommended that the funding application is approved.

#### 3. REASONS FOR RECOMMENDATIONS

- 3.1 The Council is committed to maximising the sources of income available from all sources of investment in the County.
- 3.2 This is an opportunity to upgrade facilities at the library and to enhance its ability to provide a wider range of activities so that together with the Park and Dare Theatre it will provide a cultural hub at the heart of the community.

#### 4. BACKGROUND

4.1 Treorchy Library was opened in 1971 and is a well-attended and popular facility within the town, located opposite the Park and Dare Theatre. The proximity of Treorchy Library to the Grade 2\* listed Park and Dare Theatre provides an opportunity to develop a cultural hub that will serve the town and its surrounding areas. Both the Library and the Theatre are significant buildings offering a range of provision and there is an opportunity to maximise the impact of the offer available to residents and visitors through the further development of a collaborative approach to promotion and delivery of activities, events and performances associated with literature, arts and culture in its widest sense. The Library has increasingly hosted small arts events and displays from recognised institutions, but a further widening of its activities is hampered by



the traditional lay-out of the building which now appears dated and ill-suited to facilitate the service's ambitious plans.

4.2 The Welsh Government's Museums, Archives and Libraries Division has a Transformation Capital Grant fund which is currently open for funding applications. The Council has been successful in the expression of interest phase and is now required to submit a Stage 2 application if it wishes to proceed with an application for funding for the internal re-design and refurbishment of Treorchy Library.

## 5. EQUALITY AND DIVERSITY IMPLICATIONS

5.1 There are no equality and diversity implications relevant to this report.

## 6. <u>CONSULTATION</u>

6.1 Discussions have been undertaken with relevant internal Council services, including Finance and Corporate Estates regarding the funding application and the information required to support it.

## 7. FINANCIAL IMPLICATION(S)

7.1 The Council is committed to allocating £30,000 in match-funding towards this application.

#### 8. <u>LEGISLATION CONSIDERED</u>

8.1 If the application is successful, the Council will be required to adhere to the clauses of the contract provided by Museums, Archives and Libraries Division and implement the funding as outlined in the application.

#### 9. <u>LINKS TO THE CORPORATE AND NATIONAL PRIORITIES AND THE</u> WELL-BEING OF FUTURE GENERATIONS ACT

9.1 This proposal is consistent with the priorities highlighted in the Council's Corporate Plan 'Making a Difference 2020-24', in particular contributing to:

*Ensuring People are: independent, healthy and successful Creating Places where people are proud to live, work and play.* 

9.2 It will contribute to the wellbeing goal of creating a Wales of vibrant culture and thriving Welsh language through the development of a facility that can enhance opportunities to engage with culture in its widest sense.

#### 10. CONCLUSION

10.1 Submitting an application for funding to the Museums, Archives and Libraries Division's Transformation Capital Grant Fund will provide the Council with an opportunity to attract external funding that, if successful, will be used to improve facilities at Treorchy library for the benefit of the local community.
