Introduction

In November 2018, proposals for the modernisation of residential and day care services were considered by the Council's Cabinet and it was agreed that a 12 week consultation on the Cabinet's preferred option be carried out.

The options for day care services are outlined in this booklet. The Council invites you to submit your views on the alternative options in addition to any comments that you may have on the preferred option, as well as your own suggestions on the changes being considered.

Please take this opportunity to have your say.

Background

In accordance with national, regional and local drivers for change and improvement the modernisation of adult social care provision is a key priority for Rhondda Cynon Taf Council.

People are living longer and expectations of the care and support people want and expect in later life are changing. More people need support for complex needs, like dementia and want to live independently at home. In line with the principles of the Social Services and Wellbeing (Wales) Act, the Council recognises that it needs to shape services that it delivers internally to meet current and future needs.

The Council's day services, through a day centre model, have for many years provided a traditional form of support for older people to remain independent in their own homes. Many of these day centres are showing their age, not simply in the condition of the buildings, but also in the fundamental design and purpose and therefore they do not all offer the most suitable environment in which to provide a modern service.

A new approach is needed. This should be more consistent with a wider remit that is in line with new statutory requirements and provides an improved, co-ordinated and integrated response to their care and support needs.

At the heart of the proposals is a £50m investment plan to develop extra beds across Rhondda Cynon Taf and the opportunity to create community hubs and provide facilities and services in flexible spaces more suitable for the delivery of day services for older people than currently is the case in traditional day centre models. Such opportunities to create community hubs and reduce the need for traditional older people day centres are being reviewed as part of the extra care development programme.

We have to deliver things differently as we encourage more people to be as independent and self-supporting as possible so we can concentrate our services on those who really need them and have undertaken a review of day care for older people.

Current Position

Current day services for older people in Rhondda Cynon Taf operate from traditional building based day centre settings. Adult Social Care day services for older people with an assessed care need is currently provided through 5 Day Centres:

- Tonyrefail Day Centre, Tonyrefail
- Trecynon Day Centre, Aberdare
- Riverside Day Centre, Pontypridd
- Bronllwyn Day Centre, Gelli
- Ferndale House Day Centre, Ferndale

These day centres have 25 places available per day with the exception of Ferndale House, which has a daily capacity limited to 11 places due to lack of space. They are open 5 days per week between 9.00 am and 4.00 pm with the majority of people accessing them between 10.30 am to 3.30 pm – they are not available at the weekends. The average occupancy level for all Core Day Centres is around 75%, which equates to a large unused capacity across the Service.

All of these day centres are not open to the community generally and are accessed only by people who have been assessed with a care and support need. The average number of people registered at the day centres has fallen by around 60% over the past 5 years.

It is anticipated that the overall demand for, and the level of occupancy, of these day centres for older people will continue to fall further. However, in a similar way to residential care, day service provision also occupies an important position in the spectrum of services commissioned and provided for older people by Rhondda Cynon Taf Adult Social Care.

As a Council, in 2019, we have a duty to reflect on this current model and ask ourselves whether we think it reflects the needs and aspirations of not only our current population, but the generations to come.

Preferred option

Following the review of day care services for older people, two options were provided. Cabinet's preferred option for consultation was:

Option 2: Phased decommissioning of the Council's day services as part of a planned programme of transformation in line with the proposed new service model

This option has been agreed by the Council as its preferred option following an independent review of the current day services model and would require all day service users to be assessed and supported as necessary. A planned transfer of some day care recipients would take place, with support and assessments put in place to assist them with change and to accommodate their choice whenever possible, in line with the extra care development programme.

This option is proposed for the following reasons:

- The age and original design of our 5 existing traditional day centre buildings
 means they do not all offer a suitable environment in which to provide a modern
 service. Through this building based day centre model, we have for many years
 provided a traditional form of support for older people to meet their care and
 support needs and remain independent in their own homes.
- In line with the requirements of the Social Services and Wellbeing (Wales) Act, service models need to make the best use of the resources available and focus more on prevention, early intervention and enablement to better support older people remain at home longer.
- The new model would enable the transformation of the service to provide enhanced day opportunities and contribute to the development of a day service better able to meet the changing needs and aspirations of older people in Rhondda Cynon Taf and would include the four key elements as shown below:



As part of the new model, the Council wants to change its day services model for older people to focus more on providing our services to those with complex care needs. This means that in the future our day services for older people would only support those with complex care needs and less capacity would, therefore, be needed.

By focusing day services on those with complex needs we would hope to provide a better quality service for people with complex needs, as we would be able to specialise in the needs that people have because we would be able to up skill our staff to concentrate on providing this specialist service in a way that it is currently more difficult to do because of the range of complex and non-complex needs.

People with non-complex needs would be supported by having their needs met in other ways by increasing our offer of activities and the community contribution through an expanded range of services and local area co-ordination to give and receive support.

Alternative Options

Option 1: Continue existing arrangements – Do Nothing

It is considered there would be minimal disruption to the existing day care recipients.

This option is not proposed as maintaining the status quo is not considered to be an option due to the demographic and strategic priorities identified above.
