PROPOSED TRAFFIC CALMING AND REDUCTION OF SPEED LIMIT TYLAGARW

Rhondda Cynon Taf County Borough Council has developed proposals to introduce traffic calming features and a 20mph Speed Limit in Tylagarw.

The scheme comprises a reduction of the existing 30mph speed limit to 20mph and the introduction of traffic calming features in the section of Tylagarw between the roundabout junction at the Boars Head public house, south westward to a point 55 metres west of No 1 Tylagarw Terrace. It is also proposed to reduce the existing national speed limit through Tylagarw Lane to become 40mph.


Details of the proposals are shown on the attached drawing **T2019 / 77**.
