**Y Deri and Llantrisant Road, Llantwit Fardre - Proposed Prohibition of Waiting at Any Time and Prohibition of Loading 7am – 7pm**

As you may be aware, following longstanding issues with obstructive parking on the junction of Y Deri and Llantrisant Road, the Council has developed proposals to extend the existing Prohibition of Waiting at Any Time Restrictions (double yellow lines) at the junction, and also to introduce a Prohibition of Loading 7am – 7pm Restriction along the extent of the double yellow lines on the junction.

Following a review of the existing traffic order at this location, it was found that there is an inconsistency between the traffic order and the double yellow lines currently on site. As a result, the double yellow lines on both sides of Y Deri will be extended to a length of 14 metres from the junction with Llantrisant Road.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have.
