Y Deri and Llantrisant Road, Llantwit Fardre - Proposed Prohibition of Waiting at Any Time and Prohibition of Loading 7am – 7pm

Following longstanding issues with obstructive parking on the junction of Y Deri and Llantrisant Road, the Council has developed proposals to extend the existing Prohibition of Waiting at Any Time Restrictions (double yellow lines) at the junction, and also to introduce a Prohibition of Loading 7am – 7pm Restriction along the extent of the double yellow lines on the junction.
