

(TEMPORARY ROAD CLOSURE) ORDER 2021

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for works to be carried out on or near the road in connection with a bridge examination

The effect of the Order will be to close Mountain Ash Bridge, from its junction with New Road / Ffrwd Crescent to its junction with Commercial Street

Alternative Route

From the north eastern side of the closure, proceed via Ffrwd Crescent, A4059 New Road, Mountain Ash Cross Valley Link Road, Miskin Road, Oxford Street/Henry Street to the south western side of the closure


From the south western side, reverse the directions given above.

Access **WILL NOT** be maintained for emergency services

Access will be maintained for pedestrians

The closure is expected to be in operation between 7am and 6pm on Sunday 18th July 2021, or until such time as the works have been completed.
