AND ONE WAY TRAFFIC) ORDER 2022

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for embankment works to be carried out on or near the road

The effect of the Order will be :-

Temporary One Way Traffic

Llwyncelyn Road, in a north westerly direction only, from its junction with Leslie Terrace to its junction with Pontypridd Road

Duration: 6am on 14th February to 4pm on 15th April 2022

Temporary Road Closure

Llwyncelyn Road, from its junction with Leslie Terrace to its junction with Pontypridd Road

Alternative Route – via Pontypridd Road, Eirw Road, A4058 (Porth Relief Road) and Llwyncelyn Road

Duration: Overnight closures between 8pm – 7am the next day, from Monday (evening) 14th February to Monday (morning) 21st February 2022

Access will be maintained for pedestrians and emergency service vehicles
