**(TEMPORARY ROAD CLOSURE) ORDER 2022**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for works to be carried out on or near the road for the repair and refurbishment of the White Bridge

The effect of the Order will be to close The White Bridge between Berw Road and The Parade, Pontypridd

**Alternative Route**

From the southern side of the closure, proceed via The Parade, West Street, Bridge Street Roundabout, Bridge Street and Berw Road to the northern side of the closure.

From the northern side of the closure, proceed via Berw Road, Bridge Street, West Street, Middle Street, Bonvilston Road and The Parade to the southern side of the closure.

Access **WILL NOT** be maintained for emergency service vehicles

The closure is expected to be in operation during the following dates, or until such time as the works have been completed:-

- from 8:00am on 16th May 2022 to 8:00am on 30th January 2023

Pedestrian access will be maintained for the majority of the closure with the exception of at the start and end of the contract, to erect and dismantle scaffold
