(TEMPORARY ROAD CLOSURE) ORDER 2023

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to facilitate carriageway resurfacing works

The effect of the Order will be to close Gwaun Bedw, from its junction with High Street to the junction with Bedw Street and St John's Street

Alternative Route – available via High Street and Bedw Street

Access will be maintained for pedestrians and emergency service vehicles

Access to premises will be maintained

The closure is expected to be in operation between the following dates and times, or until such time as the works has been completed:-

- **Daytime closure between the hours of 8:00am – 4:00pm from 14th – 21st August 2023**
