**Cwmbach Road, Abernant, Aberdare – Double Yellow Lines in vicinity of former Aberdare Girls School.**

Following the re-development of the former Aberdare Girls Schools, there is a requirement to amend some of the existing waiting restrictions in the area.

Restrictions that had previously facilitated the movement and waiting of buses at school drop off and pick up times, are no longer required and minor amendments to the Traffic Regulation Order are required to reflect what is now in place.

With this in mind, RCT Council is seeking to formalise the changes in the vicinity of the school, by creating a new Traffic Regulation Order (TRO).

Details of the changes are shown on the attached drawings **TM23/217/GA**, which may also be viewed at [www.rctcbc.gov.uk/traffic](http://www.rctcbc.gov.uk/traffic). *It is important to emphasise that no new changes are being made, the new TRO is to reflect and formalise what is now in place.*

The next stage in the process is to give Public Notice of the scheme where details of the scheme are advertised to provide opportunity for members of the public to formally raise any comments they may have. If you wish to comment, you should do so in writing by **22 December 2023**, to the Traffic Services Manager, Traffic Management, Sardis House, Sardis Road, Pontypridd, CF37 1DU or alternatively by email at [trafficservices@rctcbc.gov.uk](mailto:trafficservices@rctcbc.gov.uk)
