**HYSBYSIR DRWY HYN** fod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf ("y Cyngor") yn bwriadu gwneud Gorchymyn o dan Adranau 1, 2, 4, 32, 35, 45, 46 a Rhan IV o Atodlen 9 o Ddeddf Rheoleiddio Traffig 1984 ("y Ddeddf") a phob un o'r holl bwerau galluogi eraill, a'i effaith fydd:

2. Cyflwyno'r cyfyngiadau aros sydd wedi'u nodi yn Atodlen 2
3. Cyflwyno parcio i breswylwyr sydd wedi'u nodi yn Atodlen 2

#### **ATODLEN 2 – Gwahardd Aros ar Unrhyw Adeg**

##### **1. Heol Cwm-bach**

- a. Ochr ogleddol Heol Cwm-bach, o ochr ddwyreiniol ei chyffordd â Heol Plasdraw, tua'r dwyrain am bellter o 28 metr.
- b. Ochr ogleddol Heol Cwm-bach, o'i chyffordd â Heol Plasdraw, tua'r gorllewin am bellter o tua 39 metr.
- c. Ochr ogleddol Heol Cwm-bach, o bwynt 58 metr tua'r gorllewin o'i chyffordd â Heol Plasdraw tua'r gorllewin am bellter o tua 16.5 metr.
- d. Ochr ogleddol Heol Cwm-bach, o'i chyffordd â Heol Abernant, tua'r dwyrain am bellter o tua 169 metr.
- e. Ochr ddeheuol Heol Cwm-bach o'i chyffordd â Heol Abernant, tua'r dwyrain am bellter o tua 80 metr.
- f. Ochr ddeheuol Heol Cwm-bach, o ochr ddwyreiniol y gyffordd â'r lôn ddiennw gerllaw Rhif 1 Tai Gordon, tua'r dwyrain am bellter o tua 70 metr.
- g. Ochr ddeheuol Heol Cwm-bach, o bwynt 89 metr tua'r dwyrain o ochr ddwyreiniol ei chyffordd â'r lôn ddiennw gerllaw 1 Tai Gordon, tua'r dwyrain am bellter o 39 metr (wrth y fynedfa i Orsaf Dân Aberdâr).
- h. Ochr ddeheuol Heol Cwm-bach, o bwynt 28 metr tua'r de-ddwyrain o ochr dde-ddwyreiniol ei chyffordd â Heol Plasdraw, tua'r gorllewin am bellter o tua 89 metr.

##### **2. Heol Plasdraw**

- a. Ochr orllewinol Heol Plasdraw o'i chyffordd â Heol Cwm-bach, tua'r gogledd ddwyrain am bellter o tua 11 metr.
- b. Ochr ddwyreiniol Heol Plasdraw o'i chyffordd â Heol Cwm-bach, tua'r gogledd ddwyrain am bellter o tua 9 metr.


##### **1. Heol Cwm-bach**

- a. Ochr dde-orllewinol Heol Cwm-bach, o ochr ddwyreiniol Rhif 1 Tai Gordon i ochr orllewinol Rhif 5 Tai Gordon, pellter o 26 metr.
- b. Ochr ogleddol Heol Cwm-bach, o ffin orllewinol Rhif 1 Bythynnod Glanynys i ffin ddwyreiniol Rhif 2 Bythynnod Glanynys, pellter o 14 metr.

**(VARIATION, WAITING RESTRICTIONS AND RESIDENTS PARKING) ORDER 2023**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 32, 35, 45, 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions as specified in Schedule 2
3. Introduce residents parking as specified in Schedule 3

**SCHEDULE 1 – Variation**

1. The 'Rhondda Cynon Taff County Borough Council (Prohibition and Restriction of Waiting and Loading and On Street Parking Places) (Consolidation) Order 2012', shall be varied in that the following order shall be removed in its entirety: -  
"Rhondda Cynon Taff County Borough Council (Cwmbach Road, Plasdraw Road and Tydraw Road, Aberdare) (Prohibition of Waiting At Any Time, Prohibition of Waiting Except for School Buses, Residents Parking and Prohibition of Buses) Order 2008"

**SCHEDULE 2 – Prohibition of Waiting At Any Time**

**1. Cwmbach Road**

- a. The northern side of Cwmbach Road, from the eastern side of its junction with Plasdraw Road in an easterly direction for a distance of 28 metres
- b. The northern side of Cwmbach Road, from its junction with Plasdraw Road, in a westerly direction for a distance of approximately 39 metres
- c. The northern side of Cwmbach Road, from a point 58 metres west of its junction with Plasdraw Road in a westerly direction for a distance of approximately 16.5 metres
- d. The northern side of Cwmbach Road, from its junction with Abernant Road, in an easterly direction for a distance of approximately 169 metres
- e. The southern side of Cwmbach Road from its junction with Abernant Road, in an easterly direction for a distance of approximately 80 metres
- f. The southern side of Cwmbach Road, from the eastern side of the junction with the un-named lane adjacent to No1 Gordon Villas, in an easterly direction for a distance of approximately 70 metres
- g. The southern side of Cwmbach Road, from a point 89 metres east of the eastern side of its junction with the un-named lane adjacent to 1 Gordon Villas, eastwards for a distance of 39 metres (at the entrance to Aberdare Fire Station)
- h. The southern side of Cwmbach Road, from a point 28 metres south east of the south eastern side of its junction with Plasdraw Road, in a westerly direction for a distance of approximately 89 metres

**2. Plasdraw Road**

- a. Western side of Plasdraw Road from its junction with Cwmbach Road, in a north easterly direction for a distance of approximately 11 metres
- b. Eastern side of Plasdraw Road from its junction with Cwmbach Road, in a north easterly direction for a distance of approximately 9 metres

**SCHEDULE 3 – Residents Parking**

**1. Cwmbach Road**

- a. The south western side of Cwmbach Road, from the eastern side of No.1 Gordon Villas to the western side of No. 5 Gordon Villas, a distance of 26 metres
- b. The northern side of Cwmbach Road, from the western boundary of No.1 Glanynys Cottages to the eastern boundary of No. 2 Glanynys Cottages, a distance of 14 metres

**2. Eligible Addresses for Permits**

- a. Gordon Villas – No.1 – 5
- b. Glanynys Cottages – No. 1 and 2
