Dear Sir/Madam,

Following longstanding calls within the community, we have come up with proposals to extend the existing residential parking zone in Trawlln. This was brought about due to a belief that the “ripple effect” caused by Zone 601 has reduced on-street parking capacity from Central Square upwards.

Just to make you aware, if the council receives adequate support, then you will be included within the existing residential parking zone (Zone 601) and will be eligible to park in those shared use/resident only parking bays that are already in place. We currently seek to introduce mostly a residential parking zone with limited 2 hours, no return within 4 hours (Monday to Saturday, 8 am-6 pm) that will permit visitors, health care professionals etc. to park for a short period of time.

You will find extra information with regard to the proposed residential parking zone on drawing number: **TM23/156/IC** attached, which may also be viewed on the council’s website at www.rctcbc.gov.uk/traffic.

Please note, that whilst the introduction of a residential parking zone may provide benefits to some local residents, they are subject to a variety of conditions in accordance with the council’s existing policy. With that being said I have attached a list of frequently asked questions which should provide you with a better understanding of both the positive and negative effects of being included within a residential parking zone.

However, we do require significant levels of support from local residents for the introduction of a new residential parking zone. Therefore, I would urge all those directly affected by the plans to respond by **4th August, 2023**. If I do not hear from you by that date, the council shall assume you are not in support of a residential parking zone outside your property.

You should be aware that the Council will make no formal response to your comments at this stage. A further consultation exercise will be undertaken at the Public Notice stage, when you will have a formal opportunity to make representations on the proposals.
