ATODLEN 2 - Croesfan Sebra i Gerddwyr



ATODLEN 3 – Mesurau Arafu Traffig

 - a. O bwynt 12 metr i'r gogledd-orllewin o ochr ogledd-orllewinol ei chyffordd â Ffordd Fynediad Ysgol Gynradd Llanilltud Faerdref, tua'r de-ddwyrain am bellter o 25.6 metr.
2. **Ffordd Fynediad Ysgol Gynradd Llanilltud Faerdref, Pentre'r Eglwys**
 - a. O ganol ei chyffordd â Heol Sant Illtyd am bellter o 5 metr tua'r gogledd-ddwyrain

(WAITING RESTRICTIONS) ORDER 2024

(PEDESTRIAN CROSSING) NOTICE 2024 AND (TRAFFIC CALMING MEASURES) NOTICE 2024

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act proposes the following and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions on the roads identified in Schedule 1
2. Establish a Zebra Pedestrian Crossing at the location specified in Schedule 2

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

3. Raised Full Width Junction Table (75mm high), to be provided at, or within the vicinity of the location specified in Schedule 3

Objections to the proposal together with the grounds on which they are made must be sent in writing to the Traffic Manager, Sardis House, Sardis Road, Pontypridd, CF37 1DU or by email on trafficservices@rctcbc.gov.uk by 22nd February 2024.

SCHEDULE 1 – Prohibition of Waiting At Any Time

1. **The Parade, Church Village** – western side, from its junction with St Illtyd's Road to the common property boundary of No. 16 and No. 17, in a southerly direction for an approximate distance of 14 metres.
2. **The Parade, Church Village** – eastern side, from its junction with St Illtyd's Road, in a southerly direction for a distance of 16.3 metres.

SCHEDULE 2 – Zebra Pedestrian Crossing


1. To be established 7.5 metres north west of the north western side of its junction with the Llanilltud Faerdref Primary School Access Road

SCHEDULE 3 – Traffic Calming Measures

Raised Full Width Junction Table to be provided, at or within the vicinity of the following location:

1. **St Illtyd's Road, Church Village**
 - a. From a point 12 metres north west of the north western side of its junction with the Llanilltud Faerdref Primary School Access Road, in a south eastwards direction for a distance of 25.6 metres
2. **Llanilltud Faerdref Primary School Access Road, Church Village**
 - b. From the centre of its junction with St Illtyd's Road, for a distance of 5.2 metres in a north easterly direction
