

**Notice of Pre-deposit (Preferred Strategy) Public Consultation for  
Rhondda Cynon Taf County Borough Council's  
Revised Local Development Plan (2022-2037)**

Rhondda Cynon Taf County Borough Council (RCTCBC) has prepared the pre-deposit proposals documents for the plan stipulated above. Once adopted, the Revised Local Development Plan (RLDP) 2022-2037 will replace the existing, adopted Local Development Plan 2006-2021, becoming the basis for all land use planning decisions within Rhondda Cynon Taf.

The Council are inviting comments on the pre-deposit proposals documents, which outline the Vision, Growth and Spatial Options, Preferred Strategy, and Strategic Policies for Rhondda Cynon Taf. Comments are also invited on the Candidate Sites listed in the Candidate Sites Register (CSR), which were submitted during the Call for Candidate Sites process. Other documents published include the Integrated Sustainability Appraisal Report, Habitats Regulations Assessment Screening Report and a suite of Background Evidence Base Papers.

Representations deemed to be duly made and submitted within the stipulated consultation period above, will be acknowledged and formally considered when preparing the Deposit RLDP.

Representations may be accompanied by a request to be notified, at a specified address, that the RLDP has been submitted to the Welsh Government for Independent Examination and of the adoption of the plan.

The Authority is only required to consider representations made in accordance with this notice.

The independent Inspector carrying out the Examination in public will not consider representations made during this pre-deposit stage. There will be a further opportunity for representations to be made during the Deposit consultation. The representations made at the Deposit stage of consultation will be those considered by the Inspector at the Examination stage.
