# REPORT OF DIRECTOR OF PUBLIC HEALTH, PROTECTION AND COMMUNITY SERVICES

#### Author: David Batten, Head of Leisure, Parks & Countryside

#### 1. <u>PURPOSE OF THE REPORT</u>

1.1 The purpose of the report is to propose pricing levels for all leisure fees and charges in 2019 (excluding Leisure for Life Membership).

#### 2. <u>RECOMMENDATIONS</u>

- 2.1 To agree the proposed price increase of 2.9% for leisure fees and charges (excluding Leisure for Life membership), to be effective from 1<sup>st</sup> January 2019.
- 2.2 To instruct the Head of Leisure, Parks and Countryside, to make arrangements for the revised prices for 2019 to be published.

#### 3. <u>REASONS FOR RECOMMENDATIONS</u>

3.1 To enable changes to the Council's fees and charges (excluding Leisure for Life membership) to become effective from 1<sup>st</sup> January 2019 (in line with Cabinet's decision on 12<sup>th</sup> February 2015 – recommendation 2.2.4).

#### 4. <u>BACKGROUND</u>

- 4.1 On 12<sup>th</sup> February 2015, Cabinet agreed to implement future increases in leisure fees and charges from 1<sup>st</sup> January each year rather than the 1<sup>st</sup> April, with the report setting out the reasons for the change.
- 4.2 In line with the above, where price increases have been agreed by Cabinet since this time, the changes have been dealt with via a separate report to the Council Wide Fees and Charges Report presented to Cabinet in February each year.
- 4.3 Following on, on 28<sup>th</sup> September 2017 Cabinet agreed a revised pricing structure for "Leisure for Life" memberships which included a price freeze until January 2020.



#### 5. PROPOSED LEISURE FEES AND CHARGES for 2019

- 5.1 As part of considering pricing levels on an annual basis, the Council takes account of, amongst other things, the forecasted budget position for the year ahead, the current Consumer Prices Index (CPI) inflation level and the level/quality of 'service offer' in place.
- 5.2 An update on each area is set out below:
  - The forecasted budget position for 2019/20 the forecasted 'budget gap' for the Council as a whole, based on the Provisional Local Government Settlement 2019/20, is £5.920M.
  - The CPI rate (as at November 2018) is 2.4%.
  - The level/quality of 'service offer' in place the Council has continued its long term programme of investment in Leisure Services and, in 2018, delivered significant improvements to swimming pool changing rooms at Bronwydd Swimming Pool and Abercynon Sports Centre. In addition, the complete redesign and refurbishment of Rhondda Fach Sports Centre will be completed in early 2019.
- 5.3 Based on the above information, it is proposed that a 2.9% increase to Leisure Services fees and charges (excluding Leisure for Life Membership) represents a reasonable price level for 2019/20. The proposal recognises the importance of fees and charges as a key source of income to support the continued provision of top of the range facilities and also takes account of the context the Council is operating within in terms of a significant overall 'budget gap' for the year ahead and the current rate of inflation.

#### 6. EQUALITY AND DIVERSITY IMPLICATIONS

6.1 An Equality Impact Assessment screening form has been prepared for the purpose of the report. It has been found that a full report is not required at this time.

#### 7. <u>CONSULTATION</u>

7.1 There are no consultation implications arising from these proposals.

#### 8. <u>FINANCIAL IMPLICATION(S)</u>

- 8.1 Based on the proposal, the estimated additional income that would be generated in a full year is £61k.
- 8.2 The Council's Medium Term Financial Plan already assumes an increase of approximately £46k as part of the standard inflation assumptions, therefore, the net additional income would be £15k.



#### 9. LEGAL IMPLICATIONS OR LEGISLATION CONSIDERED

9.1 There are no legal implications associated with these proposals.

#### 10. <u>LINKS TO THE CORPORATE AND NATIONAL PRIORITIES AND THE</u> WELL-BEING OF FUTURE GENERATIONS ACT

- 10.1 The continuing price freeze on Leisure for Life memberships will continue to provide both value for money and reduced pricing for specific groups. This reduced pricing, for residents that require financial assistance, supports the Cwm Taf Well-Being objective of 'Healthy People'.
- 10.2 The revised pricing structure for other fees and charges ensures that the Council can still deliver effective Leisure Services that form the focal point for residents to live independent and fulfilled lives, using sport and recreation as the tool for engagement.

#### 11. <u>CONCLUSION</u>

- 11.1 The decision to freeze prices until January 2020 ensures that the Council's "Leisure for Life" offer remains competitive and affordable.
- 11.2 The increase in other leisure fees and charges, including pay and play rates, will ensure that "Leisure for Life" membership is the best option for the residents of Rhondda Cynon Taf to enjoy the health and fitness benefits of the Council's Leisure Centres and Swimming Pools.
