#### 1. DECISION MADE:

### Agreed -

1. In respect of **School Admission Arrangements** as detailed in paragraph 5 of the report at appendix 1 the proposal be amended as follows: -

That the implementation be delayed until September 2014 thereby not disrupting existing full-time attendance during the academic year and giving parents and carers more time to make any amended child care arrangements prior to the start of the September term. Also to provide full time education from the term after a child's fourth birthday rather than from the September after a child's fourth birthday as originally proposed.

This will produce savings in a full year of £3.7M.

2. In respect of the proposal relating to **Meals on Wheels** as detailed in paragraph 6 of the report at appendix 1 the proposal be adopted as detailed in the report.

This will produce savings in a full year of £0.3M

3. In respect of the proposal relating to the **Library Service** as detailed in paragraph 7 of the report at appendix 1 be amended as follows: -

To ensure a better geographical spread is achieved in respect of the Library Service in the Rhondda that Porth library be retained and that Tylorstown library be closed. This will provide better access to a library provision around the North of Taff-Ely, namely the Tonyrefail and Gilfach Goch areas.

With two facilities in and around the lower Pontypridd area there is limited access in the Western side of Taff-Ely. To address this, and to better cover Pontyclun, Llanharry, Llanharan and Brynna, it was decided that Pontyclun library be retained and Rhydyfelin library be closed.

It was therefore agreed that the following libraries be retained

In the Rhondda – Ferndale, Tonypandy, Treorchy and Porth In Cynon Valley – Hirwaun, Aberdare, Mountain Ash and Abercynon In Taff-Ely – Pontyclun, Pontypridd, Church Village and Llantrisant

This will produce savings in a full year of £0.8M

4. In respect of the proposal relating to **Youth and E3 Provision** as detailed in paragraph 8 of the report at appendix 1 be adopted as detailed in the report.

This will produce savings in a full year of £2.2M

5. In respect of the proposal relating to **Day Centres** as detailed in paragraph 9 of the report at appendix 1 be amended as follows: -

To retain Gilfach Goch Day Centre and close Pontyclun Day Centre as it was felt that there are a number of alternative services available to residents in Pontyclun which is not the case in Gilfach Goch

It was therefore agreed that the following Day Centres be retained

In the Rhondda – Porth, Maerdy, Gelli and Williamstown In Cynon Valley – Aberdare and Mountain Ash In Taff-Ely – Pontypridd, Tonyrefail and Gilfach Goch

This will produce savings in a full year of £0.6M

The need to consider service change proposals required as part of the Council's medium Term Service Planning arrangement, specifically in the context of the need to reduce spend and enable the Council to fulfil its statutory responsibility and set a balanced budget from 2014/15 onwards. Together with the need for Cabinet Members to review and consider the results of the comprehensive consultation exercise that ended on the 2<sup>nd</sup> December, 2013 and the Equality Impact Assessments completed for each proposal.

#### 3. CONSULTATION UNDERTAKEN PRIOR TO DECISION BEING MADE:

 Report to Cabinet – 21<sup>st</sup> October, 2013 resulting in a four week comprehensive consultation exercise ending on the 2<sup>nd</sup> December, 2013.
