## WELSH GOVERNMENT FUNDING PROGRAMME – TOWN CENTRE GREEN INFRASTRUCTURE AND BIODIVERSITY

### 1. PURPOSE OF THE REPORT

- 1.1 The report provides details on the Welsh Government's Town Centre Green Infrastructure and Biodiversity Funding Programme.
- 1.2 The purpose of the report is to seek approval for the submission of two applications to the Town Centre Green Infrastructure and Biodiversity Funding Programme by the deadline of 31 January 2020.

#### 2. RECOMMENDATIONS

It is recommended that:

2.1 The applications identified in the report are submitted to Welsh Government by the deadline of 31 January 2020.

#### 3. REASONS FOR RECOMMENDATION

- 3.1 The Green Infrastructure and Biodiversity Programme provides an opportunity to invest in greening projects that will deliver significant environmental benefits. This will have a positive impact on the town centres contributing to their regeneration and longer term sustainability.
- 3.2 Any funding secured through this Welsh Government Funding Programme will add value to the investment already taking place in the Parks and the town centres.

#### 4. BACKGROUND

- 4.1 Welsh Government's newly launched 'Transforming Towns' programme recognises that many towns are struggling with the decline in retail sales and that the way town centres are used is changing. 'Transforming Towns' is a wider approach to transforming town centres which recognises their importance to environmental, economic, social and cultural well-being in Wales.
- 4.2 As part of this overall package of support, one of the key investments is the 'Town Centre Green Infrastructure and Biodiversity Programme' which will support greening projects which will deliver environmental benefits, making town centres more attractive places to live, work and visit.

## 5. TOWN CENTRE GREEN INFRASTRUCTURE AND BIODIVERSITY PROGRAMME

- 5.1 There is £5million available across all Wales and funding can be for pilot or demonstrator projects. The support will be primarily aligned to town centres within the existing Targeted Regeneration Initiative (TRI) boundaries for Rhondda Cynon Taf this is Pontypridd Town Centre. However if the support is requested for a proposal outside of a TRI priority town, the application will need justify this request including detail of other investment activity being delivered in the area.
- 5.2 There is no set intervention rate but availability of match funding from non-Welsh Government will strengthen an application. Projects can be stand alone, an add-on to projects being delivered through other programmes or as a retro-fit to existing buildings/sites. There is no upper or lower limit to the size of a project, however if projects are small scale, Welsh Government would expect to see multiple interventions in the town centre for impact.
- 5.2 Applications made to the Town Centre Green Infrastructure and Biodiversity Programme must;
  - Be for capital costs only
  - Be complete, or substantially complete by 31 March 2021.
  - Address the 5 core Green Infrastructure principles of being multi-functional, biodiverse, adapted for climate change, health, smart and sustainable.
  - Be designed and delivered in a way that ensures long-term sustainability. and a minimal requirement for revenue commitment in future years.
  - Demonstrate a positive impact on town centres and placemaking.
  - Contribute to health and wellbeing in the town centre environment.

#### 6. PROPOSED APPLICATIONS

A summary of the applications is set out below;

### 6.1 'Pretty Ponty' Mill Street, Pontypridd Town Centre

- The scheme proposes the installation of raingardens and tree pits, which will manage an existing surface water flooding issue affecting the gateway. The proposals are designed to provide an adaptive form of flood alleviation that is resilient for the future taking into account the effects of climate change.
- The project is aimed at contributing to the 'place making' of Pontypridd Town Centre, through targeted development of a Green corridor. The works propose to deliver a multifunctional space within one of Pontypridd's Gateways where local bus stops and Town Center parking provisions are located.

## 6.2 'Trees for the 21st Century' - Ynysangharad War Memorial Park and Aberdare Park

 The scheme proposes the planting of ornamental trees in Ynysagharad War Memorial Park and Aberdare Park as part of pilot scheme to support the development of a 'Trees for the 21st Century' strategy. This will contribute to a quality landscape, improving the townscape, encouraging biodiversity and creating a positive impact on the wellbeing of the community.
