# 1. PURPOSE OF THE REPORT

The purpose of this report is to provide Members with a detailed analysis of the Estyn Inspection Report outcomes during the Academic Year 2015/16.

#### 3. BACKGROUND

- 3.1 The main aim of the work of the Education and Lifelong Learning Directorate is to raise standards of achievement and attainment for all learners. The legislative basis for this responsibility is the 1998 Standards and Framework Act that requires LAs and schools to have raising standards as their overriding aim.
- 3.2 Until August 2014 all education settings across Wales were subject to an inspection by Estyn the Welsh Government inspectorate at least once during a six-year period.

3.3 Schools that are subject to follow-up after inspection need regular monitoring by challenge advisers to ensure progress is rapid and robust.

# 4. EDUCATIONAL PERFORMANCE

## Outcomes of Estyn Inspections during the academic year 2015/16

- 4.1 During the academic year 2015/16, 4 non-maintained settings, 15 primary schools and 4 secondary schools were subject to an Estyn inspection. As previously reported, the inspection cycle is now open with no expected timescale, this open cycle has been apparent across all sectors. A further 6 primary schools and 1 secondary school have been subject to follow-up activities.
- 4.2 The outcomes for 2015/16 are as follows:-

## 5. **CONCLUSION**

- 5.1 It is obvious from the figures that whilst we are successful in bringing schools out of a monitoring activity, too many schools are placed in a follow-up compared to the rest of Wales.
- 5.2 To improve inspection outcomes:
  - The consortium need to continue to develop leaders at all levels to ensure succession planning is robust and there is confidence that new leaders will have the skills to move schools forward. (Leadership & Prospects for Improvement)
  - Challenge advisers need to work with HT and senior leaders to ensure that self evaluation reports and school improvement plans are fit for purpose and clearly evaluative (Improving Quality)
  - Challenge Advisers need to challenge headteachers to demonstrate impact of activities on standards and ensure they have sight of the relevant evidence. Governors too, need to take ask questions of headteachers and senior leaders in relation to how standards can be raised in their schools.
  - Headteachers need to ensure that all teaching across their school is at least good and tackle underperformance swiftly in line with regional policy.
     The LA and Challenge Adviser need to work closely with the chair of governors where underperformance is in relation to the headteacher.
  - LA and Central South Consortium need to ensure that the excellent practise seen in our schools (in the main related to Partnership working) is shared across the LA and region.
  - The figures relating to wellbeing are, in the main depressed due to judgements on attendance; whilst improving attendance will remain a priority for the LA, Estyn will no longer be using this as a driver to judge wellbeing as adequate.
