163 APPLICATIONS RECOMMENDED FOR APPROVAL

(1) Application No 13/1361: Erection of four bungalows (Additional ecological information received 26/03/15 and 09/02/15 and amended plans received 08/06/16 showing revised site access, additional footway on Garth Wen, re-located turning head and reduced front patio area to plot 3), land adjacent to "Garth Wen", Garth Road, Trealaw.

The Committee **RESOLVED** - to defer the application for a site inspection to be undertaken by the Development Control Committee for the substantial reason, to consider drainage, highways, structural issues and the impact of the development on the surrounding area.

(2) Application No: 16/0538 - Proposed conversion of former club to 1 no. three bedroom house and 6 no. one bedroom units (revised description following amended plans), 10-12 Maddox Street, Clydach, Tonypandy.

In his report, the Service Director, Planning set out details of the application recommended for approval.

The Committee considered the proposal and it was **RESOLVED** to approve the application in accordance with the recommendations of the Service Director Planning.

164 DEFERRED APPLICATION

Application No: 16/1319 – Conversion to 8 flats and shop on ground floor, external parking, amenity areas and demolition of rear annexe, Central Hotel, Clydach Road, Tonypandy.

Pursuant to Minute No.143 (Development Control Committee, 2ND March 2017) when Members were minded to refuse the above-mentioned application contrary to the recommendation of the Service Director, Planning because they considered that the proposal was overdevelopment of the site and that insufficient parking was provided as part of the development, the matter was deferred to the next appropriate meeting of the Development Control Committee for a report from the Service Director, Planning, if necessary in consultation with the Director, Legal & Democratic Services, upon the strengths and weaknesses of taking a decision contrary to recommendation, prior to determining the matter.

The Service Director, Planning reported that if, after considering his report, Members were still minded to refuse the application, the reason suggested in his report reflected their views.

Following consideration of the matter, it was **RESOLVED** contrary to the recommendation of the Service Director, Planning, to refuse the application for the two reasons set out in the report and an additional reason, the wording of which be delegated to Service Director Planning, that the proposal to develop the site for 8 flats together with the existing service deliveries to the site would adversely affect highway safety .
