Brief Description	Tref Y Rhyg Primary School is a 3 to 11 English medium primary school located at The Avenue, Tonyrefail with
	a statutory school aged pupil (reception to year six) capacity of 157 pupil places. Tref Y Rhyg Primary School currently has 4 classes, 3 of which are made up of mixed year groups.
	Tref Y Rhyg Primary School was constructed circa 1899. There is one main building, comprising of Foundation Phase and Key Stage Two teaching blocks. According to the condition survey of the school carried out by Rhondda Cynon Taf County Borough Council (RCTCBC) in 2022, Tref Y Rhyg Primary School is graded C for condition and D for suitability, where A is the highest and D is the lowest performing building, respectively. This means that in terms of condition, Tref Y Rhyg Primary School is operational but major repair or replacement needed in the short to medium term. In terms of suitability, Tref Y Rhyg Primary School is bad and comprised of buildings that seriously inhibit the staff's ability to deliver the Curriculum for Wales. The site itself and the school building does not fully comply with the Equality Act 2010 and is graded D for accessibility meaning there are significant access issues.
	This proposal seeks formal approval to begin the relevant and required statutory school organisation consultation to close Tref Y Rhyg Primary School in line with the requirements of WG's (WG's) School Organisation Code (2nd Edition) (011/2018) and to transfer its pupils to Tonyrefail Community School. This proposal will extend and expand upon the positive outcomes delivered through Welsh Government's

Sustainable Communities for Learning Programme, enabling more pupils to benefit from this significant investment which has included the provision of the new Tonyrefail Community School building.

Tonyrefail Community School is a 3 to 19 English medium all-through school located at Gilfach Road, Tonyrefail with a statutory school aged pupil (reception to year six) capacity of 385. Tonyrefail Community School was part of a wider £44 million leisure and education investment locally, which saw the nearby Tonyrefail Leisure Centre receive a new 3G sports pitch for school and community use – along with specialist teaching facilities for physical education classes to be held at Tonyrefail Leisure Centre. As Tonyrefail Community School is a new school, it is graded A for condition and A for suitability. The building has been built to meet the required standards and regulations, allowing pupils of Tonyrefail Community School to benefit from a learning environment fit for 21st century education. Tonyrefail Community School also has facilities that are regularly used by the local community ensuring that others are benefitting from the new resources available. The site and the school building are fully compliant with the Equality Act 2010.

To note, the current catchment area of Tref Y Rhyg Primary School sits within the larger catchment area of Ysgol Gynradd Gymraeg Tonyrefail (YGG Tonyrefail), and as is already the case and in accordance with the WG's School Admissions Code 2013 (05/2013), choosing a school is a parent and carer choice. As such, pupils of Tref Y Rhyg Primary School have the option to attend YGG Tonyrefail, the local Welsh medium primary school. RCTCBC's Welsh Language Immersion team provide support to any pupils that wish to move from the English medium education sector into Welsh medium education and this provision will be available to any pupils that may wish to utilise it. YGG Tonyrefail has capacity to accommodate any pupils of Tref Y Rhyg Primary School who may wish to move into Welsh medium education at their local Welsh primary school as opposed to continuing with English medium education at Tonyrefail Community School.

What are the aims of the policy, and how do these relate to the Welsh Language?

The aim of this policy is to begin the relevant and required statutory school organisation consultation to close Tref Y Rhyg Primary School in line with the requirements of the WG's School Organisation Code and to extend the catchment area of Tonyrefail Community School. Tref y Rhyg Primary school currently sits within the

catchment area of YGG Tonyrefail and therefore it will be subject to parental choice to move into the nearest Welsh medium school should they wish to do so.

All Councils in Wales must produce a Welsh in Education Strategic Plan (WESP). The WESP is a long-term language planning tool which sets the direction for the strategic planning, delivery and growth in Welsh medium and Welsh language education. Through the WESP, and effective strategic planning and investment, RCTCBC aims to contribute significantly to achieving the vision of one million people in Wales being Welsh speakers by 2050, as set out in Cymraeg 2050.

There are seven outcomes within RCTCBC's WESP. If this proposal were to go ahead and families within the vicinity choose their local Welsh medium school instead, this would support RCTCBC with achieving two of the seven outcomes in particular:

- More three year old/nursery learners to receive their education through the medium of Welsh.
- More five year old/reception learners to receive their education through the medium of Welsh.

The aim is to embed positive habits and attitudes towards the Welsh language through purposeful planning to promote the informal use of the Welsh language amongst pupils inside and outside schools. Facilitating the use of the Welsh language across the curriculum and in wider contexts in schools, to ensure a continuum of linguistic progression to support pupils in the transition between year groups, offers all pupils the opportunity to become fully bilingual and aligns with the new Curriculum for Wales.

Any impact on Welsh language groups should be positive as the closure of Tref Y Rhyg School could result in parents/carers within the current catchment area of the school choosing Welsh medium education at YGG Tonyrefail, rather than continuing with English medium education at Tonyrefail Community School. Support from RCTCBC's Welsh Language Immersion provision is available and will be promoted to parents/carers of children currently attending Tref y Rhyg Primary School.

Current linguistic profile of the geographical area(s) concerned

Every ten years the nation sets aside one day for the Census – a count of all people and households. The Census is a key source of information about the number of people who can speak Welsh.

The 2021 Census figures regarding the Welsh language show a decrease in the percentage of Welsh speakers across Wales to 17.8%. There was, however, a small increase in RCT – the percentage of the population of the County Borough who can speak Welsh increased from 12.3% to 12.4%. Numerically, RCT saw a 2.8% increase in the number of Welsh speakers in the County Borough, from 27,779 speakers to 28,556 speakers. RCT was also one of only four Local Authorities in Wales to see an increase in the percentage of Welsh speakers – the others were Cardiff, the Vale of Glamorgan and Merthyr Tydfil. These are all neighbouring County Boroughs, which could demonstrate that our region is seeing some positive trends in terms of increases in Welsh speakers, and that there may be a resulting increase in demand for services through the medium of Welsh. As further, more detailed, data from the Census becomes available for RCT (e.g., LSOA data), we will need to consider what impact it may have on the services we provide.

Tonyrefail Community School has facilities that are regularly used by the local community. The headteacher of Tonyrefail Community School will be encouraged and supported to consider utilising these facilities to increase participation in the Welsh language by offering the opportunity for parents/carers and other members of the community to attend Welsh classes and/or other opportunities for community engagement through the medium of Welsh. The Welsh medium school in this geographical area is YGG Tonyrefail which is less than a mile (0.6) away from the school. The headteacher of YGG Tonyrefail will also be encouraged to consider utilising any community use or available space at the school to increase participation in the Welsh language. These opportunities could include hosting Welsh for Adults lessons and/or any other Welsh language promotional events.

In recent years, support has been given to promote and increase pupils use of the Welsh language in primary and secondary schools in social contexts. This has been done through the Welsh Language Charter (Siarter laith/Cymraeg Campus), developed by Gwynedd Council, and various other projects, in partnership with the Central South Consortium Joint Education Service (CSCJES) and the Urdd. The 'Cymraeg Campus' Welsh Language Charter (Siarter laith/Cymraeg Campus) programme is part of a series of WG programmes which aim to increase children and young people's use of Welsh in informal situations and contributes to WG's Cymraeg 2050 strategy. It's an important tool to increasing the social use of Welsh in Wales, no matter linguistic background. Both Tref y Rhyg Primary School and Tonyrefail Community School have engaged with this programme. Tref Y Rhyg Primary School are currently working towards achieving their bronze 'Cymraeg Campus' award. As Tonyrefail Community School is an all-through school, the school chose to complete the programme as a whole school, involving pupils from both the primary and secondary sector of the school.

Tonyrefail Community School have achieved their bronze and silver 'Cymraeg Campus' awards and are currently working towards achieving their gold award.

An evaluation conducted in July 2023 whilst gathering information and data for the WESP Annual Review Report evidenced the positive impact the 'Siarter laith/Cymraeg Campus' programme has had on the use of the Welsh language in English medium schools. All schools participating in the exercise reported an increased use of incidental Welsh throughout the school with more children playing yard games through the medium of Welsh and more assemblies being held with focus on the Welsh language, history and heritage. The continued roll out of this programme will support the WG's target of reaching one million Welsh speakers in Wales by 2050 and the targets set out in RCTCBC's new WESP (2022 to 2032).

RCTCBC recognises the importance of immersion in the Welsh language for pupils who wish to transition from English to Welsh medium education. In July 2022 funding was approved by the WG to establish Welsh language immersion provision for latecomers to the language. This provision opened to pupils from September 2023, adapting a peripatetic model of delivery with the immersion teacher travelling to the schools of pupils accessing the service to immerse pupils in the Welsh language. The provision continues to evolve and demand for the service continues to grow. When demand for the service surpasses the capacity of the service, RCTCBC will consider creating a dedicated Welsh language immersion unit for latecomers alongside the development of its Band B Sustainable Communities for Learning programme.

Other relevant data or research

The language category and standards of alternative/neighbouring schools

RCTCBC has seventeen Welsh medium primary schools located throughout the County Borough to ease access. There are two all-through schools for 3 to 19 year olds, namely Ysgol Garth Olwg and Ysgol Llanhari, two dual language primary schools for 3 to 11 year olds, namely Dolau Primary and Heol y Celyn Primary and 13 Welsh medium primary schools for 3 to 11 year olds. All pupils who attend these schools' study through the medium of Welsh. From September 2024, the dual language school at Heol y Celyn Primary will transition to being wholly Welsh medium, taking the new name of Ysgol Gynradd Gymraeg Awel Taf.

The nearest Welsh medium primary school to Tref Y Rhyg Primary School is YGG Tonyrefail, which is less than a mile (0.6) away from the school. YGG Tonyrefail has capacity for 328 pupils from reception to year 6 and currently has 170 pupils attending in this age range, resulting in surplus capacity available to accommodate an increased number of pupils (PLASC January 2024). Both Tref Y Rhyg Primary School and YGG Tonyrefail are under the 1.5 mile distance allowed within the home to school transport eligibility and there are safe walking routes to both schools. As such, pupils residing in the current catchment area of Tref Y Rhyg Primary School will not be entitled to free home to school transport. This provides equal opportunity for parents/carers to decide which medium of education they would like to pursue.

Pupils attending YGG Tonyrefail transition into secondary education at Ysgol Llanhari which is 8 miles away from Tref Y Rhyg Primary School. At present, pupils attending Tref Y Rhyg Primary School transition into secondary education at Tonyrefail Community School, which is 1.2 miles away.

The nearest Welsh medium childcare and early years setting is Cylch Meithrin Cwm Elai which is situated on the school site of YGG Tonyrefail. The Cylch Meithrin offers sessional care sessions between the hours of 09:00 to 12:00 and 12:00 to 15:00.

RCTCBC recognises the importance of the WG's Cymraeg 2050 target and how central the education system in Wales is to achieve its vision. RCTCBC's new WESP (2022 to 2032) sets out a ten year vision for increasing and improving the planning of the provision of Welsh medium education in order to maximise its contribution of achieving the target of one million Welsh speakers in Wales by 2050.

In line with the new WESP (2022 to 2032), RCTCBC will continue to ensure the benefits of Welsh medium and Welsh language education are promoted to parents/carers from the initial early years, through to primary and secondary education and onwards through to higher and further education for all pupils, whatever their learning need. This is done through ongoing promotion of Welsh medium education, in general through sharing promotional videos which have been prepared. These videos include promoting Welsh medium education on a while, Welsh medium education for learners with additional learning needs (ALN), transition arrangements between primary and secondary schools and Welsh medium post-16 education. The videos are available on the RCTCBC website and have been posted on the corporate social media platforms over August and September 2024. In addition to these resources, Mudiad Meithrin have shared a series of videos focussing on promoting Welsh medium childcare and early years provision, addressing some of the concerns parents/carers have around making the choice to attend Welsh language provision. These videos will be used in different marketing campaigns at varying times throughout this academic year. RCTCBC's WESP Officer and Welsh Language Immersion Lead attend public events such as the Teddy Bears Picnic and Parti Ponty to distribute RCTCBC's Being Bilingual booklets and Welsh language immersion leaflets to the wider public. In addition, Menter laith and Cymraeg i Blant are currently working with RCTCBC to host new Welsh language events targeted at pre-school children and their families. Attending these types of events provides invaluable opportunities to speak directly with families who may be considering Welsh medium education but also have some concerns or queries. The Council's Being Bilingual booklets have also been distributed to the NHS Health Visiting team who place copies in the new baby packs, birth registration services who provide copies to parents/carers as they register new births and to local housing developers in this area of the County Borough where many new developments are underway.

What is the language category of the school included in this proposal?

Tref Y Rhyg Primary School is an English medium primary school.

What facilities are there for members of the community to learn Welsh or undertake activities through the medium of Welsh?

The newly built school at Tonyrefail Community School has facilities for community and third party use to offer opportunities for the local community to host different sessions and events at the school. The school regularly hosts community sessions which are well attended and have been a success in the local area. Included in these sessions are Welsh evening classes which are currently being held in the community facilities at the school. If this proposal goes ahead, RCTCBC will work with the headteacher of Tonyrefail Community School to encourage the school to offer further opportunities through the medium of Welsh at the school, for example inviting Welsh language groups to utilise the facilities to host Welsh language events to increase the offer of Welsh activities available in this area of the County Borough.

Pupils who wish to continue with English medium education at Tonyrefail Community School will have opportunities to use the Welsh language at the school in line with the new Curriculum for Wales and the activities required to reach the bronze, silver and gold 'Cymraeg Campus' Welsh Language Charter awards. As mentioned above, incorporated into the new school build were facilities for community and third-party use to offer opportunities through the medium of Welsh. Staff and visitors to the school are openly encouraged to use the Welsh language with each other and with pupils. All signage at Tonyrefail Community School is bilingual and in adherence to the most recent guidelines available with 'Welcome to use Welsh' signs placed in the school reception to make people aware that they are welcome to use Welsh if desired.

Further to this, RCTCBC recognises the importance of immersion in the Welsh language for pupils who wish to transition from English medium education into Welsh medium education, so as to further encourage the uptake of Welsh medium education in the County Borough. RCTCBC has adapted a peripatetic model of delivery with the immersion team attending the schools of pupils accessing provision. Networking, marketing and stimulating demand for late immersion in the County Borough has been identified as a key driver for further promoting this service and as such, promotional videos have been prepared. These videos involve pupils who are accessing the service, parental/carer interviews and headteacher interviews. RCTCBC will launched a targeted marketing campaign across the summer term with immersion being one of the key focuses of the campaign. This targeted approach is needed in order to achieve the results required to deliver the targets and commitments of our WESP (2022 to 2032).

How parents/carers and pupils' engagement with any alternative school and any specific language enhancement it offers could be supported?

RCTCBC have developed a 'Being Bilingual' booklet which has information on the benefits of receiving a bilingual education, outlining the pathway to Welsh medium education and answering some frequently asked questions around the option of choosing Welsh medium education. The booklet is distributed via Flying Start provisions, birth registration services and childcare settings. The booklets have been provided to housing developers in the Taf Ely area of the County Borough where there are large housing developments underway, to be provided to any potential new buyers in their sale packs. In addition to this, RCTCBC's WESP Officer and Welsh Language Immersion team attend local events to distribute resources to the general public. This includes events throughout RCT such as the Teddy Bears Picnic and Parti Ponty, both of which are held in Ynys Angharad Park, Pontypridd, on an annual basis. More recently, local Welsh language organisations arranged free events for pre-school children and families. An initial event was held in Trebanog in March 2024 and a further event held at Llantrisant Leisure Centre in June 2024. Following the success of these events, local Welsh language organisations are working in collaboration with RCTCBC to further develop these events for the current academic year. Plans are currently underway for 2024-25 with the aim to host at least 1 event in each area of the County Borough through the academic year. This will provide an opportunity for all in RCT to attend their local event and receive information on the options and support available to them on the journey to becoming bilingual.

RCTCBC's 'Starting School' booklet also provides parents/carers with a range of information including advice on choosing a school, the provision of home to school transport and a directory of schools. Amendments have been made to the 'Starting School' booklet to include information relating to Welsh medium education in RCT, along with information on the new Welsh language immersion provision, ensuring this information is readily available to parents/carers. This will be available to see in the new booklet for the upcoming academic year (2024-25).

Cymraeg i Blant run free baby group sessions each week throughout the county borough. These sessions are bilingual and include baby massage, baby yoga and Welsh rhyme time. This provision ensures that parents/carers receive key early messages during the ante-natal and post-natal period and are made aware of the bilingual pathway available for their child and the Welsh medium offer available locally. The nearest Cymraeg i Blant baby group is situated in Waun Wen Community Centre, Trebanog and runs every Wednesday from 10:00.

RCTCBC's Youth Engagement and Participation Service work with Welsh language organisations such as Menter laith and the Urdd to deliver bespoke language awareness sessions for young people, highlighting the

value of having the Welsh language as a skill. The Youth Engagement and Participation Service also deliver social events and activities for young people through the medium of Welsh which include residential opportunities, eisteddfodau, sport and accreditation.

In July 2022 funding was approved by the WG to establish Welsh language immersion provision for latecomers to the language. The provision, now established and gaining momentum throughout RCT, adopts a peripatetic model of delivery with the immersion lead officer engaging with pupils accessing the service to become immersed in the Welsh language. When demand for the service surpasses the capacity of the service, RCTCBC will consider creating a dedicated Welsh language immersion unit for latecomers alongside the development of its Band B Sustainable Communities for Learning programme.

Information on how the proposal fits with the WESP and any future actions that will be needed in consequence of the change to continue to comply with the scheme or meet targets in the scheme.

RCTCBC believes that all pupils should have appropriate opportunities for learning in the mediums of both Welsh and English to enable them to develop the confidence to use both languages in everyday life in order to meet the demands of the 21st Century.

RCTCBC recognises the importance of the WG's Cymraeg 2050 target and how central the education system in Wales is to achieve its vision. RCTCBC's new WESP (2022 to 2032) sets out a ten-year vision for increasing and improving the planning of the provision of Welsh medium education within the county borough, in order to maximise its contribution of achieving the target of one million Welsh speakers in Wales by 2050. It builds on the work of the previous WESP (2017 to 2022) and sets out an action plan which demonstrates how we intend to achieve our ten-year vision.

If this proposal were to go ahead and parents/carers residing in the current catchment area of Tref Y Rhyg Primary school choose their nearest primary school, which is YGG Tonyrefail, this will support both outcome 1 and 2 of the WESP, which aim to increase the number of nursery and reception aged pupils receiving their education through the medium of Welsh. The continued uptake of the 'Cymraeg Campus' Welsh Language Charter will support Outcome 5 of the WESP which focusses on providing more opportunities for learners to use Welsh in different contexts in school.

The key to successfully achieving the outcomes outlined within RCTCBC's WESP is effective marketing and promotion of Welsh education on a whole. Over recent months, RCTCBC have created a range of promotional videos encompassing the seven outcomes of the WESP. These videos include teacher recruitment, Welsh language immersion, Welsh medium ALN education, Welsh medium post-16 education and transition. Footage

has been prepared involving practitioners who currently work in schools in RCT, headteacher and teacher interviews, parental interviews and interviews with pupils who currently attend Welsh medium schools. These videos will form part of a wider targeted marketing campaign specifically focussing on growing numbers in the Welsh medium education sector. This campaign was launched during an event at the National Eisteddfod whilst it visited RCT in August 2024. Since then, the videos have been posted on RCTCBC's corporate website and across social media platforms. For the period of September to November 2024, a marketing campaign will be implement across the social media platforms to raise the awareness of Welsh medium education in RCT.

The majority of the Welsh medium primary schools in the County Borough have sufficient surplus places to meet demand. However, there are a number of schools where demand is close to outstripping supply. As such, RCTCBC has or is currently taking action to address these issues through a number of projects and proposals. Projects that will address this issue include the recently completed expansion of Ysgol Gynradd Gymraeg Aberdar, including a purpose built Welsh medium childcare facility; as well as the new Welsh medium primary school in Rhydyfelin (Ysgol Gynradd Gymraeg Awel Taf) to accommodate pupils at Ysgol Gynradd Gymraeg Pont Sion Norton and the Welsh stream at Heol y Celyn Primary School, the expansion of YG Rhydywaun with a new teaching block and sports facilities; and the planned new school building to serve the Llanilid housing development. Furthermore, RCTCBC has also committed to increasing the quality and availability of early years Welsh medium provision by investing significantly in a number of provisions through various funding schemes, such as the WG's Welsh Medium Capital Grant. This will assist in ensuring a language continuum of Welsh medium provision and ensure that increased demand for Welsh medium education is met.

Headteachers of Tref Y Rhyg Primary School and Tonyrefail Community School will be encouraged to promote and signpost to the Welsh medium early years and primary education provision available at YGG Tonyrefail and Cylch Meithrin Cwm Elai. This will be done by distributing promotional resources such as the 'Being Bilingual' booklet and the Welsh language immersion provision leaflets to families residing in the area and in local public venues and also signposting to the Welsh medium education section of RCTCBC's website which contains further information which promotes the Welsh language and Welsh education in RCT.

No changes to these proposals are required in order to comply with the WESP.

In order to create more Welsh speakers, our education system is dependent on its school based workforce, and we must work locally, regionally and nationally to ensure we create a school based workforce with robust linguistic skills, able to inspire and motivate pupils in Welsh medium and Welsh language education.

In recent years, support has been given to promote and increase pupils' use of the Welsh language in primary and secondary schools in social contexts. This has been done through the introduction of the Welsh Language Charter

The WG's ambitious Cymraeg 2050 strategy calls for farreaching changes and boundaries being pushed to increase the numbers learning and using Welsh. To achieve the Cymraeg 2050 targets of reaching a million Welsh speakers in Wales by 2050, each local authority needs to transform how Welsh is taught Officer each quarter via the CSCJES Welsh Language Officer.

A Welsh Language Impact Assessment has been completed and the main findings are as follows -

The proposal is to close Tref y Rhyg Primary School with pupils transferring to Tonyrefail Community School.

Tonyrefail Community School was part of a wider £44 million leisure and education investment locally, which saw the nearby Tonyrefail Leisure Centre receive a new 3G sports pitch for school and community use – along with specialist teaching facilities for physical education classes to be held at Tonyrefail Leisure Centre. As Tonyrefail Community School is a new school, it is graded A for condition and A for suitability. The building has been built to meet the required standards and regulations, allowing pupils to benefit from a learning environment fit for 21st century education. The site and the school building are fully compliant with the Equality Act 2010.

To note, the current catchment area of Tref Y Rhyg Primary School sits within the larger catchment area of YGG Tonyrefail, and tailored and individual support will be available from RCTCBC's Welsh Language Immersion Team for any pupils wishing to continue their education, at YGG Tonyrefail, through the medium of Welsh.

Although Tonyrefail Community School is an English medium primary school, Welsh is taught as part of the curriculum and all pupils will benefit from having the opportunity to be taught in brand new facilities fit for the 21st century.

RCTCBC aims to embed positive habits and attitudes towards the Welsh language through purposeful planning to promote the informal use of the Welsh language amongst pupils inside and outside schools. Facilitating the use of the Welsh language across the curriculum and in wider contexts in schools, to ensure a continuum of linguistic progression to support pupils in the transition between key stages, offers all pupils the opportunity to become fully bilingual and aligns with the Curriculum for Wales 2022. Tonyrefail Community School will continue to be encouraged and supported to do this through the achievement of the 'Cymraeg Campus' Welsh Language Charter, a framework to promote and increase the use of Welsh.

Tonyrefail Community School also has facilities that are regularly used by the local community ensuring that others are benefitting from the new resources available. Tonyrefail Community School will be encouraged to invite Welsh language groups to utilise the space available to host any other Welsh language group classes/sessions at the school.

This could contribute towards the WG's ambitious goal of creating a million Welsh speakers in Wales by 2050 and the WESP.
