

(TEMPORARY ROAD CLOSURE) ORDER 2019

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to temporarily close Taff Street, from its junction with Crossbrook Street, southwards for a distance of 10 metres

The restriction is necessary to enable works to be executed on or near the road in connection with the replacement of a town centre bollard

The closure is expected to be in operation between 7:00am – 7:00pm on the following Sundays or until such time as the works have been completed

25th August 2019	19th January 2020
1st September 2019	26th January 2020
5th January 2020	2nd February 2020
12th January 2020	9th February 2020

Alternative route – from the northern side of the closure, proceed via Gelliwastad Road, Catherine Street and Sardis Road to the southern side of the closure


NB – The “Mid Glamorgan County Council Pontypridd – Central Area Traffic Regulation Order No.1 1979” will be temporarily suspended where it refers to one way traffic in Penuel Lane, to allow the existing direction of the one way to be reversed to allow access for local traffic into the town centre

Access for emergency services **WILL NOT** be maintained

Access for pedestrians will be maintained

Access will be maintained for local traffic only Penuel Lane to premises in the Town Centre
