2. Y Stryd Fawr, y lôn tua'r de, o'i chyffwrdd â Stryd Seymour i'w chyffwrdd â Stryd Canon



(TEMPORARY ROAD CLOSURE) ORDER 2021

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for works to be carried out on or near the road in connection with the siting of a crane to carry out electricity works

The effect of the Order will be to close the following sections of roads:

1. Canon Street, from its junction with High Street, to its junction with Cardiff Street / Victoria Square
2. High Street, southbound lane, from its junction with Seymour Street to its junction with Canon Street

Alternative Route


From the northern side of the closure, proceed via Gadlys Roundabout, A4233, A4059 Aberdare Bypass, Tinneys Roundabout and Cardiff Street to the southern side of the closure.

Access will be maintained for pedestrians

Access **WILL NOT** be maintained for emergency service vehicles

The closure is expected to be in operation between 6am and 5pm on Sunday 31st October 2021, or until such time as the works have been completed.
