Taff Vale Redevelopment, Taff Street, Pontypridd.

Following redevelopment of the Pontypridd precinct area, the council have developed proposals to introduce various new on street parking measures including a taxi rank, bus stop, loading bays and disabled parking bay in Taff Street.
