Plantation Road, Abercynon - Proposed Prohibition of Waiting at Any Time Restrictions

As you may be aware, the Council have previously consulted with residents on proposals to address concerns regarding dangerous / obstructive parking near the junction of Plantation Road and the B4275 (Mountain Ash Road). It is proposed to introduce Prohibition of Waiting at Any Time Restrictions (double yellow lines) at this location.

The next stage is a period of Public Notice of the proposals, where details of the scheme are advertised to provide opportunity for members of the public to formally raise any concerns they may have.
