

1. Clustogau Arafu (75mm o uchder, 1900mm o led X 2500mm o hyd), i'w darparu yn, neu o fewn cyffiniau, y lleoliadau canlynol :-
 - a. O gyffordd Ffordd y Fynwent a Heol Caerdydd, am bellter o tua 145 metr i gyfeiriad y gogledd yn gyffredinol
 - b. O gyffordd Ffordd y Fynwent a Heol Caerdydd, pellter o tua 215 metr i gyfeiriad y gogledd yn gyffredinol
 - c. O gyffordd Ffordd y Fynwent a Heol Caerdydd, pellter o tua 285 metr i gyfeiriad y gogledd yn gyffredinol
 - d. O gyffordd Ffordd y Fynwent a Heol Caerdydd, pellter o tua 368 metr i gyfeiriad y gogledd yn gyffredinol
 - e. O gyffordd Ffordd y Fynwent a Heol Caerdydd, pellter o tua 450 metr i gyfeiriad y gogledd yn gyffredinol

(TRAFFIC CALMING MEASURES) NOTICE 2022


NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

1. Speed Cushions (75mm high, 1900mm wide X 2500mm long), to be provided at, or within the vicinity of the following locations :-
 - a. From the junction of Cemetery Road and Cardiff Road, a distance of approximately 145 metres in a general northerly direction
 - b. From the junction of Cemetery Road and Cardiff Road, a distance of approximately 215 metres in a general northerly direction
 - c. From the junction of Cemetery Road and Cardiff Road, a distance of approximately 285 metres in a general northerly direction
 - d. From the junction of Cemetery Road and Cardiff Road, a distance of approximately 368 metres in a general northerly direction
 - e. From the junction of Cemetery Road and Cardiff Road, a distance of approximately 450 metres in a general northerly direction
