Mae angen cau'r ffordd fel bod modd cynnal y gwaith arni nue yn ei hymyl



(TEMPORARY CLOSURE) ORDER 2021

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be to close A4233 Maerdy Mountain Road, from its junction with Graig Place, Aberdare to its junction with Station Road, Maerdy

The restriction is necessary to enable works to be executed on or near the road


The closure is expected to be in operation between 8am to 6pm each day from 21st July to 1st September 2021, or until such time as the works have been completed.

The alternative route for vehicles will be from the south western side of the closure, proceed via A4233 and A4058 to Pontypridd and via A470 and A4059 to Aberdare.

For vehicles travelling in the opposite direction, reverse the directions given above.

Access will be maintained for pedestrians and emergency vehicles
