Effaith y Gorchymyn fydd cau Stryd Margaret o ffin de-ddwyreiniol Rhif 43 Stryd Margaret, tua'r de-ddwyrain am bellter o 170 metr.

Llwybr Amgen – trwy Heol Aberllechau, A4233, Cylchfan Stanleytown, Stryd Llywellyn a Stryd Margaret.

(TEMPORARY ROAD CLOSURE) ORDER 2022

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary for works to be carried out on or near the road in connection with ground investigations

The effect of the Order will be to close the Margaret Street from the south eastern boundary of No. 43 Margaret Street, south eastwards for a distance of 170 metres

Alternative Route – via Aberllechau Road, A4233, Stanleytown Roundabout, Llewellyn Street and Margaret Street

Access will be maintained for pedestrians

Access **WILL NOT** be maintained for emergency service vehicles

The closure is expected to be in operation from during the following dates and times, or until such time as the works have been completed:-

- 8:00am on Saturday 19th February to 6:00pm on Sunday 20th February 2022
- 8:00am on Saturday 26th February to 6:00pm on Sunday 27th February 2022
