2. Clustogau arafu (rhwng 25 milimetr a 100 milimetr o uchder, 1900 milimetr o led a 2500 milimetr o hyd) i'w darparu fesul dau yn y lleoliad sydd wedi'i nodi yn Atodlen 2, neu yn ei gyffiniau
3. Clustogau arafu (rhwng 25 milimetr a 100 milimetr o uchder, 1700 milimetr o led) i'w darparu fesul tri yn y lleoliad sydd wedi'i nodi yn Atodlen 3, neu yn ei gyffiniau
4. Twmpathau ffyrrd lled llawn gyda phennau gwastad (15 metr o hyd, 100 milimetr o uchder) i'w darparu yn y lleoliad sydd wedi'i nodi yn Atodlen 4, neu yn ei gyffiniau

**(SPEED LIMIT) ORDER 2022 AND (TRAFFIC CALMING MEASURES) NOTICE 2022**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Introduce a 20mph speed limit on the roads identified in Schedule 1

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

2. Speed Cushions (between 25 - 100mm in height, 1900mm wide and 2500mm long), to be provided in sets of two at, or within the vicinity of the locations specified in Schedule 2
3. Speed Cushions (between 25 - 100mm in height, 1700mm wide), to be provided in groups of three at, or within the vicinity of the locations specified in Schedule 3
4. Full width, Flat Top Road Hump (15 metres in length, 100mm in height) to be provided at, or within the vicinity of the location specified in Schedule 4

**SCHEDULE 1 – 20MPH Speed Limit**

1. Llantrisant Road, Tonyrefail from a point 53 metres north of the northern boundary of No. 8, to a point 50 metres north west of the centreline of its junction with the residential development, Trem-Y-Dolau, a distance of approximately 593 metres.
2. Hafod Wen, Tonyrefail in its entirety
3. Highlands, Tonyrefail in its entirety
4. Trem-Y-Dolau, Tonyrefail in its entirety

**SCHEDULE 2 – Speed Cushions sets of two**

Speed Cushions in sets of two, at or within the vicinity of the following locations:

1. **Llantrisant Road, Tonyrefail**
  - a. At a point 32 metres north of the centreline of its junction with Trem-Y-Dolau, residential development

**SCHEDULE 3 – Speed Cushions groups of three**


Speed Cushions in groups of three, at or within the vicinity of the following locations:

1. **Llantrisant Road, Tonyrefail**
  - a. At a point 145 metres south of the centreline of its junction with Trem-Y-Dolau, residential development
  - b. At a point 61 metres southeast of the centreline of its junction with Hafod Wen
  - c. At a point, 17 metres south of the centreline of its junction with Heol TyLwyd
  - d. At a point, 80 metres south of the centreline of its junction with Heol TyLwyd
  - e. At a point, 156 metres south east of the centreline of its junction with Heol TyLwyd

**SCHEDULE 4 – Full Width, Flat Top Road Hump**

1. **Llantrisant Road, Tonyrefail**
  - a. At a point 53 metres south of the centreline of its junction with Trem-Y-Dolau, residential development
