3. Clustogau arafu (75 milimetr o uchder, 1700 milimetr neu 1900 milimetr o led x 2500 milimetr) i'w darparu fesul dwy neu dair yn y lleoliadau sydd wedi'u nodi yn Atodlen 3, neu yn eu cyffiniau
4. Byrddau arafu lled llawn wedi'i godi (75 milimetr o uchder, 6000 milimetr o hyd) i gael eu darparu yn y lleoliadau wedi'u nodi yn Atodlen 4, neu yn eu cyffiniau

2. **Rhodfa Caerefrog, Llanilltud Faerdref** – ar ddwy ochr y briffordd o'i chyffordd â Rhodfa'r Frenhines i gyfeiriad y de-ddwyrain am bellter o 8.5 metr



  - c. 22.3 metr i gyfeiriad deheuol cyffredinol o ganol cyffordd Erw'r Brenin a Bryn y Goron
  - d. 101.5 metr i gyfeiriad gogleddol cyffredinol o ganol cyffordd Hydau'r Siandler a Bryn y Goron

**PEDESTRIAN CROSSING NOTICE 2022 (TRAFFIC CALMING MEASURES) NOTICE 2022**

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act proposes the following and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions on the roads identified in Schedule 1
2. Establish a Zebra Pedestrian Crossing at the location specified in Schedule 2

**NOTICE IS HEREBY GIVEN** that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

3. Speed Cushions (75mm high, 1700mm or 1900 mm wide x 2500mm), to be provided in sets of two or three at, or within the vicinity of the locations specified in Schedule 3
4. Raised Full Width Speed Table (75mm high, 6000mm long) to be provided at, or within the vicinity of, the location specified in Schedule 4

**SCHEDULE 1 – Prohibition of Waiting At Any Time**

1. **Queens Drive, Llantwit Fardre** – on the south western side of the highway, from a point 15.85 metres north west of the centre of its junction with Queens Drive, in south easterly direction for a distance of 28.5 metres
2. **Yorks Drive, Llantwit Fardre** – on both sides of the highway from its junction with Queens Drive in a south westerly direction for a distance of 8.5 metres

**SCHEDULE 2 – Zebra Pedestrian Crossing**

1. To be established on Crown Hill, Llantwit Fardre, 18.3 metres south of the centre of the junction of Hillside Way and Crown Hill

**SCHEDULE 3 – Speed Cushions**


Speed Cushions in groups of two or threes, at or within the vicinity of the following locations:

1. **Crown Hill, Llantwit Fardre**
  - a. 19.3 metres in a general northerly direction from the centre of the junction of Chandlers Reach and Crown Hill
  - b. 19 metres in a general northerly direction from the centre of the junction of Crown Hill Drive and Crown Hill
  - c. 22.3 metres in a general southerly direction from the centre of the junction of Kingsacre and Crown Hill
  - d. 101.5 metres in a general northerly direction from the centre of its junction of Chandlers Reach and Crown Hill

**SCHEDULE 4 – Raised Full Width Speed Table**

1. Crown Hill, Llantwit Fardre – 18.3 metres in a general southerly direction from the centre of its junction if Hillside Way
