

PARKING BAYS) ORDER 2023

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council, intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The closure is necessary to maintain traffic flow during the siting of a mobile crane in the highway.

The effect of the Order will be as follows: -

Temporary Suspension of Traffic Order

The "Rhondda Cynon Taff County Borough Council (Taff Street, Pontypridd) (Variation, Waiting and Loading Restrictions, Loading Bay, Hackney Carriage Stand and Disabled Parking) Order 2022" will be temporarily suspended for the duration of the order, where it refers to the following items of the Schedules:

Schedule 4 – Loading Bay at all times.

1a Taff Street - North-western side, from a point 28.2 metres south-west of its junction with Bridge Street, in a south westerly direction for a distance of 16.5 metres.

and

Schedule 5 – Hackney Carriage Stand at all times.

1a Taff Street - North-western side, from a point 44.7 metres south-west of its junction with Bridge Street, in a south westerly direction for a distance of 26.3 metres


Access will be maintained for pedestrians and emergency service vehicles
