DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn, ar ôl o leiaf 7 diwrnod o ddyddiad yr Hysbysiad yma, o dan Adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991, a fydd yn para deunaw mis ar y mwyaf.

Effaith y Gorchymyn fydd:

- 1. Cau** Stryd yr Orsaf, Porth. Bydd y stryd gyfan ar gau.
Bydd llwybr amgen ar gael ar hyd Stryd Taf y Gorllewin, y ffordd ddienw rhwng rhif 27 a rhif 28 Stryd Taf y Gorllewin, y ffordd ddienw rhwng rhif 65 a rhif 66 Stryd Hannah, a Heol Pontypridd.
- 2. Cau** Stryd Hannah, Porth o'i ffin dde-ddwyreiniol â rhif 14 Stryd Hannah i'w chyffordd â Stryd yr Orsaf.
Bydd llwybr amgen ar gael ar hyd y ffordd ddienw rhwng rhif 65 a rhif 66 Stryd Hannah a Heol Pontypridd.
- 3. Cau** lôn ogleddol Heol Pontypridd ar ei chyffordd â Phont Cymer.
Bydd llwybr amgen ar gael ar hyd yr A4058 tua'r gogledd, cylchfan newydd pont Rheola a'r A4058 tua'r de.
- 4. Gwahardd** unrhyw gerbyd rhag mynd ar y ffordd ddienw rhwng rhif 65 a rhif 66 Stryd Hannah o'i chyffordd â Heol Pontypridd ac eithrio i gyfeiriad y de-orllewin.
- 5. Atal y darpariaethau canlynol** yn y Gorchymynion canlynol yn yr Atodlen o Orchymynion yng Ngorchymyn Cyfnerthiad (Gwahardd Cyfyngu ar Aros a Llwytho a Mannau Parcio Ar y Stryd) 2012 Cyngor Bwrdeistref Sirol Rhondda Cynon Taf .

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council intends, not less than 7 days from the date of this Notice, to make an Order under Section 14 of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991, which will have a maximum duration of eighteen months.

The effect of the Order will be

- 1. To close** the entire length of Station Street, Porth
Alternative route via West Taff Street, the unnamed road between No 27 and No 28 West Taff Street, the unnamed road between No 65 and 66 Hannah Street, and Pontypridd Road.
- 2. To close** Hannah Street, Porth from the south-east boundary of No 14 Hannah Street to its junction with Station Street
Alternative route available via the unnamed road between No 65 and 66 Hannah Street and Pontypridd Road.
- 3. To close** the northbound lane of Pontypridd Road at its junction with Cymmer Bridge.
Alternative route via A4058 northbound, the New Rheola Bridge Roundabout and A4058 southbound
- 4. To prohibit** any vehicle from proceeding in the unnamed road between 65 and 66 Hannah Street from its junction with Pontypridd Road other than in a south westerly direction
- 5. To suspend the following provisions** in the following Orders in the following Orders in the Schedule of Orders in the Rhondda Cynon Taff County Borough (Prohibition of Restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012

(i) Yr ochr dde-orllewinol o Stryd Hannah, o bwynt sydd 22 metr tua'r de-ddwyrain o'i chyffordd â Stryd yr Orsaf i bwynt sydd 79 metr tua'r de-ddwyrain o'i chyffordd â Stryd yr Orsaf, am bellter o 57 metr.

Atodiad 4 – Mannau parcio dynodedig i bobl anabl

(i) Yr ochr dde-orllewinol o Stryd Hannah, Porth, o bwynt sydd 7 metr tua'r de-ddwyrain o'i chyffordd â Stryd yr Orsaf i bwynt sydd 22 metr tua'r de-ddwyrain o'i chyffordd â Stryd yr Orsaf, am bellter o oddeutu 15 metr.

c) Adrannau canlynol Gorchymyn (Amrywio, Cyfyngu ar Aros a Man Llwytho Dynodedig) (Stryd Hannah, Porth) 2007 Cyngor Bwrdeistref Sirol Rhondda Cynon Taf.

b) The following sections of the Rhondda Cynon Taff County Borough Council (Hannah Street, Porth) (Revocation, Prohibition of Waiting and Loading at any time, Limitation of Waiting, Designated Disabled Parking Bays and Designated Loading Bays) Order 2005

Schedule 3 – One Hour Limited Waiting with Return Prohibited Within One Hour, between the hours of 8.00am – 6.00pm, Monday to Saturday Inclusive.

(i) The south-western side of Hannah Street, Porth, from a point 22 metres south-east of its junction with Station Street to a point 79 metres south-east of its junction with Station Street, a distance of approximately 57 metres.

Schedule 4 – Designated Disabled Parking Bays

(i) The south-western side of Hannah Street, Porth, from a point 7 metres south-east of its junction with Station Street to a point 22 metres south-east of its junction with Station Street, a distance of approximately 15 metres.

c) The following sections of the Rhondda Cynon Taff County Borough Council (Hannah Street, Porth) (Variation, Limitation of Waiting and Designated Loading Bays) Order 2007

Schedule – Part 3 – One Hour Limited Waiting with Return Prohibited Within One Hour, between the hours of 2.00pm – 6.00pm, Monday to Saturday Inclusive.

(i) The south-western side of Hannah Street, Porth, from a point 81 metres south-east of its junction with Station Street, to a point 99 metres south-east of its junction with Station Street, a distance of 18 metres.

Schedule – Part 4 – Designated Loading Bay

8.00am – 2.00pm, Monday to Saturday inclusive

(i) South-eastern side, from a point 10 metres north-east of its junction with Hannah Street for a distance of 15 metres in a north-easterly direction.

The restriction is necessary to facilitate resurfacing and footpath works

Access for emergency services WILL be maintained
Access for pedestrians WILL be maintained
Access to premises WILL be maintained

The Order is expected to be in operation from 15th May to 12th June 2023 or until such time as the works have been completed.
