
1. Stryd Grover, Pontypridd

- a. Ar ochr ogledd-ddwyreiniol y stryd, o bwynt 8.6 metr i'r gogledd-orllewin o ganol ei chyffordd gyda Bythynnod Cae'r Adar, ac i'r de-orllewin am bellter o 16 metr.

2. Bythynnod Cae'r Adar, Pontypridd

- a. Ar ochr gogledd-orllewinol y bythynnod, o bwynt 2 fetr i'r de-orllewin o ffin dde-orllewinol Rhif 4 Bythynnod Cae'r Adar, ac i'r gogledd-ddwyrain am bellter o 10.5 metr.
- b. Ar yr ochr de-ddwyreiniol, o bwynt 2 fetr i'r de-orllewin o'r llinell adeiladu ar dde-orllewin Rhif 16 Stryd Grover (pen y talcen), ac i'r gogledd-ddwyrain am bellter o 9.5 metr.

(WAITING RESTRICTIONS) ORDER 2024

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, and 4 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, the effect of which will be to:

1. Introduce waiting restrictions as specified in Schedule 1

Objections to the proposal together with the grounds on which they are made must be sent in writing to the Traffic Manager, 2 Llys Cadwyn, Taff Street, Pontypridd, CF37 4TH or by email on trafficservices@rctcbc.gov.uk by 9th August 2024.

SCHEDULE 1 – Prohibition of Waiting At Any Time

1. Grover Street, Pontypridd

- a. North-eastern side, from a point 8.6 metres north-west of the centre of its junction with Birdsfield Cottages, south-eastwards for a distance of 16 metres

2. Birdsfield Cottages, Pontypridd

- a. North-western side, from a point 2 metres south-west of the south-western boundary of No. 4 Birdsfield Cottages, north eastwards for a distance of 10.5 metres
- b. South-eastern side, from a point 2 metres south-west of the south-western building line of No. 16 Grover Street (gable end), north-eastwards for a distance of 9.5 metres
